
President's Perspective

Our *Medical Transportation Service* has been ensuring access to health services for residents with barriers to transportation since 1999. The program is a model of efficiency and effectiveness. We have provided hundreds of residents access to health care which might otherwise have been inaccessible.

The need for further development of transportation options for our rural population is evidenced by the continued growth of this service. In 2006 we transported 566 residents on 7366 trips covering 121,612 miles. 241 were new clients who had not used our service before. This represents a 28% increase from the previous year.



Our Medical Transportation Service includes an 8-passenger wheelchair-accessible minibus, in addition to 2 sedans, a wagon and 3 minivans.

After the medical transportation service, *Covering the Uninsured* (Columbia-Greene Facilitated Enrollment Program) is the largest program under our roof. Since it began in Winter 2003, this program has consistently ranked above average in application submissions, and generated 135% of its referral goal for the year.

2006 saw a remarkable 97% enrollment rate for Child Health Plus applicants. Of the 912 enrollments for the year, 671 were children.

Our program supports that mission and seeks access to health coverage for every eligible individual in the 2 counties.



Rip Van Winkle Tobacco-Free Coalition of Columbia & Greene Counties uses media campaigns and other activities to encourage smokers to quit, to promote smoke-free homes, cars and outdoor spaces, and to mobilize public support against tobacco industry advertising, sponsorship and promotion.

In 2006, the percentage of homes in the county where smoking is not allowed increased to 74%, and calls to the NYS Quitline nearly doubled. The Coalition began a multi-year project to eliminate tobacco advertising near schools, and worked with the Columbia County Board of Health to propose smoking restrictions around entryways of county buildings.

Cancer Support Program for Columbia and Greene has embraced an initiative to recruit cancer survivors as part of a Mentoring Network to match recently diagnosed cancer patients with survivors who offer social and emotional support.

The program has used a multi-media campaign to promote support groups and resources available to residents affected by cancer. More than 300 Cancer Services & Support directories for Columbia and Greene counties were distributed throughout the year.

Columbia County Healthy Women Partnership exemplifies our program success by exceeding established precedents year after year. In 2006 that translated to a 114% success rate providing mammographies and cervical screenings to women locally. Mobile screenings at different venues throughout the county are drawing women who might not otherwise get screened.

Not uncharacteristically, this program has received accolades from clients as well as from state and local elected officials for the work it has done.



Program Coordinator Darcy Connor has worked tirelessly to help women get screened. Mobile screenings have allowed greater exposure for the Healthy Women Partnership.

Columbia-Greene Diabetes Coalition is the local chapter of the Greater Capital Region Coalition for Diabetes Prevention & Control. This program encourages the prevention and management of diabetes through education and raised awareness.

Area providers have helped direct visitors to monthly support meetings where a certified diabetes professional presents topical information about preventing and controlling diabetes. Community-based diabetes events have also helped to dramatically increase awareness of the Coalition's presence.

Nutrition Outreach and Education Program of the Twin Counties helps eligible residents of Columbia and Greene Counties apply for Food Stamp Benefits. Many hours of community outreach with targeted marketing earned nearly 2700 contacts with potential program participants.

This program saw a 33% increase in households approved for Food Stamp Benefits in 2006. NOEP staff performed 1541 eligibility pre-screens during that same period.

The *Long-Term Care Insurance Education and Outreach Program* for Columbia County has been underway since mid-year. The program seeks to educate the residents of Columbia County about long term care insurance and all the available options to protect assets and/or ensure care during prolonged illness or old age.

Through presentations to groups and classes held several evenings at the community college, 163 residents have learned about protecting assets and options for nursing care for when they get older. This program does not recommend or endorse insurance carriers or plans, but can provide a list of participating insurance agents in the area.

Ovarian Cancer Awareness and Education Initiative for Columbia and Greene Counties seeks to provide women and medical professionals with increased awareness of the signs and symptoms of ovarian cancer. Because the symptoms can be mistaken for other, less serious illnesses, this treatable disease often goes undiagnosed.

The ovarian cancer awareness program educator has scheduled community presentations for women and medical professionals. We expect this knowledge to empower women to “ask your doctor,” and to have doctors “asking the patient.”



Consultations with health care providers will be more about good patient-doctor communication. Our program seeks to advise health professionals about the need to recognize and talk about ovarian cancer symptoms with their female patients.

Columbia County Community Partnership for Children’s Dental Health entered its fifth year bringing preventive education and dental services to pre-school and third grade children. Licensed dental hygienists provided oral health education and performed screenings at primary schools, WIC and Head Start sites in Columbia County.

330 third graders were seen by the hygienists for screenings and treatments. Of those, 195 received sealant applications on back teeth that can help to prevent cavities from developing. 37 children were referred to a dentist for treatment. Another 31 youngsters were referred to Child Health Plus for health/dental coverage.

Our *health education Speakers Bureau* was begun to meet a need to provide expert information and material on topical health issues to the public. By enlisting the expertise of providers and human services organizations in the region, presentations could be coordinated for small and large groups.

The Speakers Bureau is available to schools, businesses, civic and fraternal organizations, and clubs and social groups. This has been a particularly valuable service to senior groups, who have had presentations on topics such as First Aid, Blood Pressure & Diabetes, Osteoporosis, Beating Winter Blues and the Vial of Life emergency identification kit, to name a few.



Presentations to groups both small and large are coordinated by the Healthcare Consortium. Experts in their respective fields are available to provide health information on dozens of topics.

Prescription Access provides assistance to Columbia County residents to obtain medications from Patient Assistance Programs (PAP) at participating pharmaceutical companies. Each company's program has its own qualification process.

The program helps low-to-mid income residents file applications with the pharmaceutical companies' PAP, following the requirements set by each company. During 2006 this program served 73 residents, assisting them to obtain 242 prescription medications at low or no cost. Twenty-one clients were new to the program.



Most U.S. pharmaceutical companies make low- or no-cost prescription medications available to individuals who meet their eligibility requirements.



The Healthcare Consortium maintains a 24-hour web presence at www.columbiahealthnet.org. A monthly events calendar, listing of local resources, on-line directories and links to reputable health sites are features available on the site day and night. Visitors can expect prompt responses to queries posted to our website.

The web site is updated regularly and on average, nearly 12,000 pages have been sent to visitors each month. More than 150,000 pages were requested from the site in 2006.



24-hour health information is available from our website: www.columbiahealthnet.org. The website is updated regularly and features a monthly events calendar, a listing of local health resources, links to reputable sites, and on-line service directories.

The Healthcare Consortium is involved in many areas of health care access beyond just our program responsibilities. We represent Columbia County on several statewide groups and initiatives such as NYS Association for Rural Health, Hudson-Catskill Area Health Education Center, NYS Telepsychiatry Task Force, and the NYS Cancer Consortium.

We have conducted outreach and surveys to help us identify the greatest needs in several important areas such as long term care, transportation and youth behaviors. And board members and staff meet annually for Strategic Planning sessions where issues are dissected and resolutions are reached.



Strategic Planning sessions are an annual exercise where the board members and staff discuss issues in great detail to reach consensus and resolution for next steps.

Fiscal Year ending June 30


