The Navigator Program

In-person assistance enrolling in health insurance on the NY State of Health

2,003 inquiries answered; 1,580 applications completed; 1,872 people enrolled

NYConnects

Information, assistance and referral for individuals with long-term care needs ~436 people served

Independent Consumer Advocacy Network (ICAN)

Assistance and advocacy on behalf of residents of Columbia and Greene Counties with understanding how to enroll in and use managed care plans that cover long-term care services through Medicaid

~ 12 people served; 66 providers and 20 consumers educated

The Financial Assistance Funds

Financial support for health and other expenses for limited-resource individuals and families ~ 25 people assisted



The Tobacco-Free Communities Program

Advocacy for policy changes that make tobacco products less visible, less accessible, and denormalize tobacco use.

- 1 business adopted a policy to restrict smoking on worksite grounds
- 2 municipalities upgraded park policies to include vaping
- 24 apartments in multi-housing units became smoke-free
- 3 school districts received PowerPoint presentations, videos and other materials on tobacco use and the risks of vaping to assist with both online and classroom learning

The Prescription Access & Referral Program

Helps qualified residents of Columbia, Greene, and northern Dutchess Counties to get their prescription medications at low or no cost. ~ 115 people served



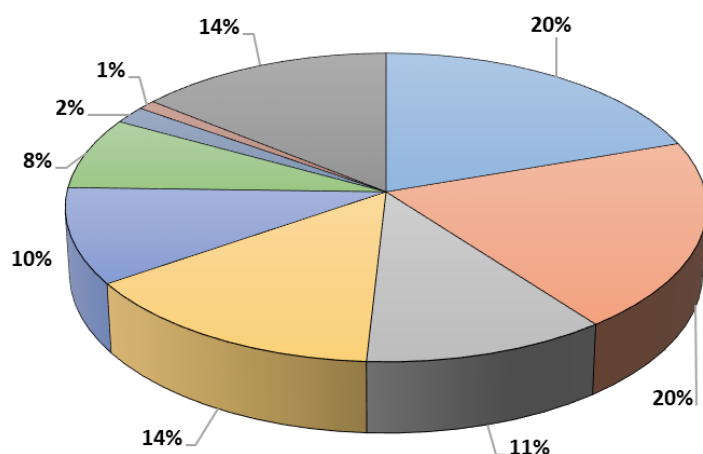
Helpers for Health Project

Helpers assisted with arranging medical transportation, childcare, and interpretation services, and in setting health goals and making a plan to achieve those goals.

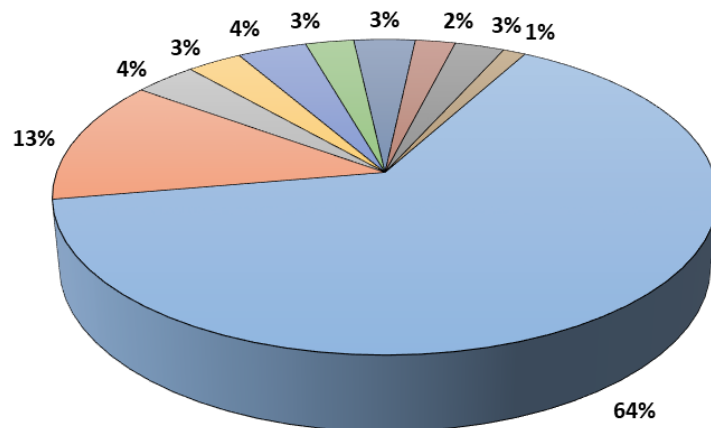
