At the Consortium, we know that nothing feels more personal—and sometimes, more fragile—than one's own health or that of a loved one. That is why we focus on providing responsive, compassionate, individualized services to help our clients overcome the **physical**, **financial**, and **practical** barriers they encounter when trying to access care.

physical

"I had surgery in January. In fact, I had two operations on my left knee because I fell after the first surgery and they had to go in again. I've been a widower for nine years, and reside by myself, after my wife of thirty-two years died shortly after contracting bacterial meningitis.

My recuperation after surgery was quite challenging. I could not negotiate the stairs to the bedroom and full bath so I slept on the first floor on a sofa bed in my home office. I was in a significant amount of pain and had to use a walker to move from my office to the kitchen. Medicare Home Health provided for visits from a nurse, and physical therapists, on condition I not drive.

I had numerous appointments with various medical specialists, but was unable to drive. I contacted Jim Funk, your Transportation Coordinator, and he was extremely helpful and professional in scheduling transportation for me to and from the appointments. And, the drivers who work for him were also highly professional and courteous. I mentioned that I live alone and during this trying recuperation I enjoyed the conversation I had with your drivers as they drove me from North Chatham to doctors in Albany, then back home.

Your staff helped me get through a very difficult period in my life and I will alway be grateful and appreciative to them, and to you."

"I got the Healthcare Consortium's information through my family doctor and my case worker, Beverly. Beverly knew I was going through a hard time financially after my husband had passed away, so she was the one that hooked me up with Rachel. I was devastated just dealing with my husband's death, and not only that, but trying to figure out what I was going to do and how I was going to pay for things, like medicine, food, and my bills. I didn't know what to do. I knew I had to take my medicine, there is no way I could cut back on that. At the Healthcare Consortium, Rachel is the one who got me some help in finding ways to cut the prices down on my drugs. Together, we filled out the paperwork and she worked with me to figure out my best options. When Rachel told me what was covered, I couldn't believe it. It's amazing where I was to where I am now, and how you guys helped me out."
